Gender & Development. 24 (2), 277-290, 2016: This article explores how women's movements in China, India, and Indonesia have mobilised to influence processes of legal reform on violence against women and girls (VAWG). Journal of Interpersonal Violence. 1-21. 2016: This study retrospectively examines associations between multiple risk factors and domestic child sex trafficking (i.e., entry into the commercial sex industry under the age of 18) in a sample of individuals aged 16 and older currently involved in the commercial sex industry. August 2016: The United Nations in South Sudan today condemned unequivocally reports of widespread sexual violence, including rape and gang rape, of women and young girls, by soldiers and unidentified armed men, stressing that such acts constitute grave violations of international human rights law and may be regarded as war crimes and crimes against humanity.
